



Press the Well Locator Tile



Find and click the green Launch button on the top right of the page



Click thru the user agreement and the begin using the +/- buttons top right of the map to hone in on the county/township/section that you are interested in viewing

For further granularity explore/ experiment with the Legends and Layers features listed vertically on the left hand side of the window - one handy modification you can make is to uncheck the Wells by Status (Active) box - this will allow you to remove shallow vertical wells from being displayed, thus only deep horizontal wells will be depicted.

Under the Search/Select a Layer, you can also search by Oil & Gas Wells, Well Pads, Core Samples, Unitizations, Parcel Search and Township Search
